INTRODUCTION

This institution provides the following allied health Science under graduate course affiliated to Kerala University of Health Sciences (KUHS).

BSc Dialysis Technology (BSc DT) – 4 Years

ELIGIBILITY FOR ADMISSION

Candidates seeking admission for the BSc DT course should fulfil the following:

- 1. Pass in Kerala State Higher Secondary Examination or equivalent as approved by Kerala University of Health Sciences with aggregate 50% marks in Physics, Chemistry and Biology taken together.
- 2. Applicant should have completed 17 years of age on 31st December 2024. For the proof of age, self-attested copy of relevant page of school record such as SSLC/CBSE/ICSE certificate or copy of birth certificate from appropriate authority should be furnished along with the application form.

HOW TO APPLY

- a. Application for admission and prospectus are available only through online mode, visit https://pimsrc.edu.in/ahs-admissions-2024 for details
- b. Only one application is required to be submitted. (Application Fee Rs. 1,500/-)
- c. The payment of application fee is only through online mode. After filling up all necessary information and details of marks the candidates have to fill the details of application fee transfer and "submit" the application. After submission of online application candidates shall take a printout of the same and submit the same to the college office before the last date shown on admission notification.

SUBMISSION OF APPLICATION

The printout of application with enclosures shall be submitted to the Principal, Allied Health Science, Pushpagiri Institute of Medical Sciences and Research Centre, Tiruvalla – 689 101, on or before the last date fixed for receipt of the same (as shown in admission notification), self-attested copies of the following certificates shall be enclosed.

- 1. SSLC certificate/ Equivalent
- 2. Plus-two certificate / Equivalent
- 3. Passport size photographs (to be affixed on application)

SELECTION

Selection of candidates will be on merit list prepared on the basis of the marks obtained in the qualifying examination (Physics, Chemistry, Biology)

Preparation of Merit List

Marks of Physics, Chemistry and Biology in Higher Secondary Examination* will be considered for preparation of merit list. If there is a tie, marks of Biology will be taken, followed by Physics and Chemistry. If all these are equal, Date of birth of candidate will be considered i.e. with person of higher age getting preference over the younger.

*CBSE/ICSE Senior Secondary Examination marks will be equated with Higher Secondary marks of Kerala Syllabus by approved normalisation process:

IMPORTANT

- 1. The tentative schedule of admission 2024 is available on website.
- 2. Candidates are advised to visit website for all notifications, registration of options, date of admission etc. and also to get updated on any change or modification in admission schedule, no personal intimation will be send in this regard.
- 3. Submission of more than one application by a candidate will lead to rejection of the application for the same course submitted subsequent to the first application.
- 4. Candidate who do not take admission in the prescribed date will lose their admission.

COURSE FEE*

The fee structure shown below is tentative. Fee is likely to change as per direction of Fee Regulatory Committee. If the fee fixed by Govt./Fee regulatory committee is more than the tentative fees will have to be paid by the candidate at the time of admission and for the entire course. If the fee fixed by the Govt./Fee regulatory committee is less than the fee paid by the candidate, the excess fee paid by the candidate shall be refunded.

DISCONTINUATION

In Case of discontinuation of course after closing admission, claim if any for liquidated damaged shall be determined by appropriate proceedings before the competent civil court. Transfer Certificate will be issued only after payment of full fees.

EXAMINATION

Regular Examination shall be conducted at the end of each year/semester. Examination fees shall be remitted by the candidate as stipulated by the university / concerned Authority from time to time at the appropriate period.

ELIGIBILITY FOR APPEARING EXAMINATION

BSc DT course examinations conducted by KUHS as per regulations of course and scheme of examinations in force from time to time.

RULES AND REGULATIONS

- 1. As per Rules and Regulations of the University regarding the conduct of students in campus, the management has a right to stall organizational activities of student organizations directly or through their member student organizations in the campus. - 6. Any type of in-disciplinary behaviour (whistling, passing comments, exhibiting posters, spreading rumours, shouting etc.) towards teachers, other students or staff will be subjected to major disciplinary actions.
- 7. Any change in the contact address/number should be informed to the college (by the parents), in the right time. College will not be responsible for any delay/missing of information/communication due to the change in address.
- 8. The institution shall not be liable in the delay/loss in communication owing to failure of postal/courier service.
- 9. Each student should report for class/clinics in the specified time. Late comers will not be allowed to attend class/clinics'.
- 10. Students should inform class teacher/concerned teacher about absenteeism in advance and should submit the leave letter in time. Absenteeism from class/clinics without prior information will be marked as double absence along with other disciplinary actions.
- 11. Assignments/projects should be submitted in time prescribed by the teacher and delay will be a reason for reduction of internal marks.
